TLA Receives \$550,000 Grant from Mellon Foundation

The Texas Library Association has been awarded a two-year grant of \$550,000 from the Mellon Foundation. This grant will support TLA's work in demonstrating the value of Texas libraries and librarians and celebrating their vital roles in our communities through research, education, and outreach. Update from the Capitol

The Texas Legislature will adjourn in 25 days, and deadlines in the House of Representatives are starting to come into play. May 12 is the last day House committees can report House bills, May 16 is the last day the full House can consider House bills, and May 24 is the last day House committees can report Senate bills. Four bills impacting libraries are advancing through the process:

- SB 412 amending the penal code to remove affirmative defense language passed both the House and Senate and will go to the Governor for signature.
- HB 3225 restricting minors' access to "sexually explicit" materials in public libraries is scheduled for a vote by the House on May 8.
- SB 2101, the Senate version of HB 3225, was left pending in the Senate State Affairs

Committee.

SB 13, establishing Local School Library
 Advisory Councils, passed the Senate, was
 heard by the House Public Education
 Committee on May 6, and left pending.
